Subject: The hot water supply to your apartment

The hot water for your building is reticulated through the building to your apartment from a central system.

Each apartment has a dedicated hot water meter and is individually charged for their hot water usage.

In some cases, apartments are also charged for gas used for operating the cooktop, so if applicable, charges for gas used by your cooktop will be shown as a separate charge on your account.

An account establishment fee and security deposit may apply.

For your convenience, we have left the gas connected to your property so you can start enjoying the benefits of hot water straight away, however you do need to contact us immediately to ensure your hot water supply continues.
